Response to your request for official information

Thank you for your request under the Official Information Act 1982 (the Act) to Manatū Hauora (the Ministry of Health) on 9 October 2023 for details of Medical Referees appointed under the Burial and Cremation Act 1964 and a list of public crematoria. You requested:

"I am unable to find a current list of the names and contact details of Medical Referees appointed under the Act on-line.

Please provide the relevant details and explain why this information is not freely available – in particular, following last night's Sunday T V programme which high-lighted the ludicrous cost of funerals in New Zealand.

Also, please provide a list of public crematoria located in New Zealand – ie Govt and/or Council-owned, not ones owned by Funeral Directors."

Manatū Hauora has identified 2 documents within scope of your request, which are itemised in Appendix 1 with copies enclosed. Where information has been withheld under section 9 of the Act, I have considered the countervailing public interest in releasing information and consider that it does not outweigh the need to withhold at this time.

Please note, all cremations must occur in an approved crematorium, except for when permission is granted by a Medical Officer of Health. Even if an individual contacts a Medical Referee directly to request permission for cremation, they will still need to contact an approved crematorium to arrange a cremation. Individuals can search online for a crematorium in their region or by contacting their local council.

Additionally, it is important to note that the documents may list people that are no longer medical referees and crematoria that have ceased operating. The Director of Public Health (within Manatū Hauora) assesses and approves applications from individuals wishing to be a Medical Referee, or from businesses that are seeking to open and operate a crematorium. There is no obligation placed upon Medical Referees or crematoria to inform Manatū Hauora when they cease to provide services.

Document 2 provides details of all crematoria currently approved to perform cremation services. This includes privately operated crematoria and those that are operated by a public entity, for example a local council.
