## Response to your request for official information

Thank you for your request under the Official Information Act 1982 (the Act) to the Ministry of Health – Manatū Hauora (the Ministry) on 7 March 2024 for information regarding the Therapeutic Products Act 2023 (TPA). You requested:

The timeframe for this request is from November 27, 2023 to the date of this request. All reports, submissions, aide memoire, emails, analysis, correspondence and communications on any platform, sent, held or received by the Ministry in relation to:

• Plans to repeal the Therapeutics Products Bill

On 11 March 2024, you were contacted by the Ministry and asked to refine your request, as it would likely require a substantial amount of time to collate. In order to provide you with the information sooner, you were asked to specify which email correspondence you were interested in. The Ministry interpreted your request to be for formal correspondence containing advice or decisions relating to the Ministry's work to progress the repeal of the TPA.

On 18 March 2024, the Ministry followed up with you on a refinement of your request and asked that you narrow your request for email correspondence to be between the Ministry and the Office of the Associate Minister of Health, Hon Casey Costello. On the same day you agreed to narrow your request for email correspondence.

The Ministry has identified two email correspondence within scope of your request. These documents are itemised in Appendix 1 and copies of the documents are enclosed. Where information is withheld, this is outlined in the Appendix and noted in the document itself.

The documents appended to these email correspondence are withheld in full under section 9(2)(f)(iv) of the Act, to maintain the constitutional conventions that protect the confidentiality of advice tendered by Ministers and officials. The advice provided to the government currently remains under active consideration and releasing this information would prejudice the orderly and effective conduct of government decision-making processes. I have considered the countervailing public interest in release in making this decision and consider that it does not outweigh the need to withhold at this time.

A further three documents were identified in scope of your request and provided to the Minister of Health, Hon Dr Shane Reti prior the delegation of the TPA to the Associate Minister of Health, Hon Casey Costello on 2 February 2024. These documents are also withheld in full under section 9(2)(f)(iv) of the Act.

While I am unable to release you copies of the briefings sent to the Ministers of Health at this time, I have provided you with a list of documents sent to the Ministers of Health:
