Response to your request for official information

Thank you for your request under the Official Information Act 1982 (the Act) to the Ministry of Health – Manatū Hauora (the Ministry) on 25 July 2024 for information regarding the Government's preparations for a new pandemic. You requested:

"The latest documents on how the NZ Govt will deal with a new pandemic in NZ and the regulations they will put in place."

Your request is refused under section 18(d) of the Act, as the information requested is publicly available. There are a number of documents that would guide the response to any future pandemic, including in particular:
