

Context


The potential of a broader system that delivers primary and community healthcare

- Timely access to high quality healthcare
- Meets local needs close to home
- Brings together different services and providers to keep people well and out of hospital
- Responds more effectively to unmet health needs, particularly for Māori
- Addresses the wider determinants of health

Context

Key challenges in primary and community healthcare

- The current system, centred around general practice, is difficult to access for many New Zealanders, which creates pressures elsewhere in the health system
- Workforce trends and changes in healthcare needs are likely to compound these pressures
- System settings and structures are not supporting the sector to deliver accessible, comprehensive, prevention-focussed healthcare



You have an opportunity to set a clear direction for primary and community healthcare

- The key challenges show that current system settings are not working to support timely access to high quality health care to all New Zealanders
- We are seeking direction on your vision for primary and community
 healthcare, which elements of the system design should be reconsidered,
 and how fundamental policy levers should be used differently
- Setting out a long-term direction will then guide which shorter-term actions
 will have the greatest impact on addressing the key challenges

There is a significant opportunity for you to set out the outcomes that the primary and community healthcare system should strive towards to support your overall health system objectives

Scope of a strategic work programme: areas to explore



Key questions to explore in setting the long-term direction



What is the **minimum set of comprehensive health services** that should be available in every community? What should be available everywhere, and what should people expect to have to travel to access?



What level of local variability in service provision is acceptable?



How should **community and iwi voice influence decisions** about how primary and community services are provided?



What structures are necessary to enhance service provision, and what should the role of a meso-layer be?



How should all players in the system be supported to **deliver on outcomes**?

Phasing a strategic work programme

- Realising fundamental shifts will take time, require foundational system changes, and need sector-wide support.
- There are short and medium-term opportunities to address the key challenges in ways that align with longer-term aims.
- We are seeking your views on which system changes are your highest priority

Short and medium term

Target short-term actions towards alleviating immediate pressures in the primary and community healthcare system while starting a shift towards your strategic objectives

Longer term

Combine these actions with a **strategic** and longer-term programme that **sets a clear direction** for the future.

Addressing issues with resourcing


 Funding arrangements for primary care have largely remained the same since the early 2000s, with many reports over recent years recommending changes.

We can provide you with detailed advice on a phased approach to improving funding, which could include:



Improving targeting of lower-cost care

- Health entitlement cards include the Community Services Card (CSC), the High Health User Card (HUHC), and the Pharmaceutical Subsidy Card (PSC).
- Target lower cost or free access to services to those with greater needs, largely based on income (CSC) or health needs (HUHC and PSC).
- Eligibility settings have not been reviewed for several years so may not align well to needs.



Continued focus on Māori health gains

Kaupapa Māori services have proven effectiveness at reaching and caring for Māori (COVID-19 vaccination, COVID-19 care and resilience), have built high levels of trust, and take a holistic and comprehensive approach to also address determinants of health
