Background

- 1. The Government Policy Statement on Health 2024–2027 (GPS) sets out the Government's priorities and objectives for the publicly funded health sector in New Zealand for the three years from July 2024 to June 2027.
- 2. The interim GPS that is currently in place expires on 1 July 2024 and the GPS you are tabling at SOU will be the first full GPS on Health published under the Pae Ora (Healthy Futures) Act 2022.
- 3. The Cabinet paper and an iteration of the GPS content were circulated for Ministerial and coalition consultation from 6–15 May 2024. No significant feedback was received as a result of the consultation, though we did receive some agency feedback which resulted in some amendments referenced in our briefing to you on 15 May [H2024041338].
- 4. Your office lodged the paper for consideration at Cabinet Social Outcomes Committee (SOU) on 22 May 2024.

- 5. The accompanying Cabinet paper (**Appendix 1**) seeks approval from SOU to endorse the GPS on Health 2024–2027, which will be published before 1 July 2024.
 - a. The final content of the GPS is attached as **Appendix 2.**
 - b. Talking points to support you at SOU are attached as **Appendix 3**. These include some summary points and some topics that you might get asked about.

6. Following your discussion at SOU, we will support you to make any amendments to the GPS to reflect feedback from the SOU members before the Cabinet meeting on 27 May 2024.
