#### Item 1: Discussion on the approach for the next Action Plan

• Minister Chhour is proposing an approach to the second Action Plan that will set out the broad strategic priorities alongside a phased programme of action.



- A phased programme of action is proposed, with an immediate focus <u>s 9(2)(f)(iv)</u>, understanding current spend and ensuring that specialist FVSV services are accessible and effective.
- The next phase will build on this and draw on the Impact Review to understand funding, impact and opportunities for reprioritisation.
- The Ministry is supportive of this phased approach.

# Item 2: Update on the Social Investment Agency FVSV Impact Review

- The Social Investment Agency (SIA) are continuing their work to understand and evaluate existing FVSV spend, supported by Te Puna Aonui Business Unit. The work aims to understand existing spend and impact and enable Ministers to make informed decisions on reprioritisation and any new investment.
- The Ministry of Health and Health New Zealand will continue to feed in and support this review and work to understand any implications or opportunities for health-related investment or reprioritisation.
