Who should submit an annual return

Specialist Vape Retailers

- If you hold an **approved vaping premise (AVP)** approval, you will need to complete **one** return for **each specialist vaping premises**.
- If you hold an **approved internet site (AIS)** approval, you will need to complete **one** return for **each online specialist store**.
- See pages 4-15 of this user guide

Importers and Manufacturers (notifiers)

- A business that imports or manufactures vaping, herbal and smokeless tobacco products must complete one return.
- See pages 4-15 of this user guide

General Vape Retailers (e.g. supermarket, petrol station, diary)

- For general retailers who sell vaping, herbal, and smokeless tobacco products each business that holds the regulated product seller (RPS) notification must provide one return. Note this may cover multiple stores.
- See pages 16-27 of this user guide

Submission successful

You should receive an email confirmation shortly. If there are any errors in your submission you will receive an additional email. You will need to fix these errors before your return is complete

If you are a specialist vape retailer, you must enter your total sales of nonnotifiable products e.g food and drinks. To do so, you must review your return after the validation is completed, you will receive a link to review

- If you need to submit another return, click start new submission. You will be taken back to select a new licence code, go to page 5 of this user guide.
- If your upload is complete, you will receive an email within 15 minutes to confirm that your return has been validated.
- Note specialist vape retailers need to provided their net revenue for nonnotifiable products e.g. food and drinks.
- Click on the link in the email to complete this step. Refer to page 11 for guidance on this step.

- If you are a general retailer of notifiable products (vaping, herbal smoking or smokeless tobacco) and have not submitted and paid for a regulated product seller (RPS) notification. Please complete the following steps:
 - 1. Use this <u>link to HARP</u>
 - 2. Log back in, click into 'new submission', and click 'Regulated Product Seller Notification (RPS)'. The RPS is the notification/registration required for general retailers of vaping products. The RPS form may also be visible on the landing page when you first log in – both take you to the same place.
 - 3. Fill out the RPS form, pay the invoice and you're good to go.
- Note you may begin the return without an RPS notification; however, you will be asked to provide an RPS code before submitting the return.
